



# **EUROPE AGAINST DISCRIMINATION**

DECLARATION ON RACISM AND XENOPHOBIA BY THE EUROPEAN COUNCIL

The European Council notes with concern that manifestations of racism and xenophobia re steally growing in Europe, both in the Member States of the Community and elsewhere.

The European Council stresses the undiminished validity of international obligations, with regard to combating discrimination and racism to which the Member States have committed themselves within the framework of the United Nations, the Council of Europe and the CSCE.

The European Council expresses its convition that respect for human dignity is essential to the Europe of the Community and that combating discrimination in all its forms and therefore vital to the European Community.

The European Council asks Ministers and the Commission to increase their efforts to combat discrimination and xenophobia.

On 2 and 3 May 1991 an International Symposium was held in Leiden. The Symposium "Europe against discrimination: vigilant for democracy and freedom" was organized at the initiative of the Joint Resistance Foundation and the Anne FRank Foundation, in close cooperation with Leiden University.

The weel over three hundred participants at the symposium represented organization of former resistance members and presecuted persons, movement against racism and discrimination, educational institutes, a broadly-based delegation of AEGEE representing thousands of students throughout Europe, and institutions from non-EC countries.

One important point of discussion was, what specific contribution

can be made by the European Youth?

The representatives from the international organizations present at the symposium make their contribution by emphasising the necessity of setting up a so called 'platform', which enables them to present a united front to the European Community the European Parliament and the Council of Europe.

This 'platform' could be created until the year 1995 and after a lot of activities organized by differnt groups of society.

The network of AEGEE throughout Europe could provide a framework where different ideas will be expressed, but wher common actions lead to an important practical approach.

#### AEGEE-Europe therefore proposed:

- 1. to found a Working/Coordination Group called "Europe Against Discrimination" during the Presidents' Meeting in Krakow. The Working Group should consist of those willing to develope activities together withe the antennae Comité Directeur. Furthermore they should be the link between the initiators and AEGEE-Europe with regard to coordination and information.
- 2. to organize a one-day conference before the Agora of AEGEE-Europe in November 1992. This event could be the first opportunity to cooperate i.e. with the

Anne Frank Foundation and to gain their support.

3. to organize a common action in May 1993 together with as many as possible antennae throughout Europe.

to motivate our members to launch and to develope their own activities.

The next meeting with the initiators will be on the 28th of February in Rotterdam. I will inform you at the PM in Krakow.

I'm looking forward to your reaction, with best wishes



MODERN **COMMUNICATION WITHIN** 

As we all know, AEGEE is a dynamic student organization which has its local antennae over the entire surface of Europe. Many seminars, congresses and other activities have been organized and will be organized within AEGEE, A good communication between the organizing parties is therefore a critical element in the success of these events.

Many communication problems can arise and, as Murphy says, will arise. In the past Murphy's law has been proved right too many times. But, a dynamic and young organization like AEGEE likes to look at these problems in a modern way. Let us do so,

Which kind of problems are we talking about? I stated them below in order of importance:

- 1. Lack of general information from/of all kinds of events, which could be useful for the organizers
- 2. Mail arriving too late
- 3. Costs of travelling for meetings

In this letter I want to express some ideas, which can solve these problems partially or totally. I'm going to think of an electronic solution, because the services, which electronic mail and similar services provide, are not very dependend of civil servants, Electrons run faster anyway.

Let's look at the problem in the terms descrived above.

1. LACK OF GENERAL INFORMATION ...:

When information is needed, a lot of times people have to look everywhere. They have to ask almos everybody if he has the information or, if not, ehrer to find it, it would be so much easier if you only had to go to one place for asking it. Therefore we must design a general system which contains all information within AEGEE. This we can do by creating a memorybank in a computer environment, in which the information is contained. By dividing this memorybank in parts (e.g.

CD, EnvWG, EWWG, etc.) called directories, we can order the information logically.

If you have databases or programs or letters which are important for everybody in AEGEE, you can put them in such a directory, This is called 'uploading'. Everybody who thinks this file/program is useful for him can fetch it and put it on his floppy disk. This is called 'downloading'.

A number of AEGEE-antennae has a connection with EARN (European Academic Research Network). Through this network, we are already able to send each other letters, files and other data. There is only one problem. Not all antennae have a connection to EARN.

When a general system is made, the same one mentioned in point 1., you only need to have a computer which is connected to a network connected to other international networks. Most universities have a lot of them. (For insiders: If you find a PC connected to such a network with the TELNET- or KERMIT command, you don't need to ask for an account from the system rator, Costs are zero.). You then enter the general system and mail the things you want,

3. COSTS OF TRAVELLING FOR MEETINGS:

This can be solved, until now, in only one way: Don't travel. This is possible if we can create electronic rooms for meetings. This is called a CHAT service. Think about the following:

-Create the general system in which you can create channels. A participant of an electronic

meeting has to join a room and give his name, under which he will be known in the meeting. Once he has joined (by invitation or not), then whatever he types onto his screen, will also appear on the screens of the other persons which joined this meeting. Imagine the following protocol:

- 5 persons want to have a meeting about East-West Working Group. It is a public meeting,

so everybody can join. They call each other on the phone and make an appointment. An appointment is a time, on whoch the meeting will take place, and the name of the room (E.G. room-EWWG')

- All the participants mail in advance some papers and letters to the central general system. In this way everybody can fetch and read them for their perparation of the meeting

 At the time the appointment takes place, a participant can log himself into the general system. He then chooses the CHAT-function, gives his name and gives the name of the room he wants to join (?+EWWG')

Now he has joined the meeting. The meeting takes place...

-Create an application which will make automatically the minutes (more a logbook which contains all what has been said).

-Define several protocols in which meetings can take place. (What is the role of the president of the meeting; Can everybody speak at one time or must the president give permission to speak;

-Distribution of the minutes/papers to the participants or all people known to the general system. -Creation of public and private rooms. To public rooms everybody can join without invitation. To private channel only invited people can join.

Creation of a one to one express-message system. If you want to say something to another person, you send a message to him. It will appear on his screen and split a second after you typed the last letter.

-Creation of public bulletin-rooms. Everybody can put a message on a certain bulletin-room. This message can be ready by anyone who is logged into the general system.

-One has to keep in mind: This is only possible for small meetings

All of this has to be kept a simple as possible

Almost every university has some computers who have 'telnet'-command. (Or others like Kermit etc.). The best is that people who want to log into the general system only have to use this command. The rest will be taken care of by the general system. It has one disadvantage: It can be sloww, because every typed letter has to be sent to the general system (which can be 1000's kilometers away) and back

We want to develop this idea into a working system. When the system is operational, people are neede to work with it. Else, all the work would be in vain. For promoting this idea we need the support of AEGEE-Europe and its members. If you are interested, pleas contact us. Also for questions and ideas you can contact us.

## **EUROPE ON 5 ECUs PER DAY**

Well, I tried to write a short story on this subject, but I ran into another one of my limitations; it turned out shitty! Well, it'll have to be the boring "practical tips" format ...

#### TRAVELLINT

The cheapest way is to hitchhike, walk or cycle, of course. Now hitchhiking is faster, but it's important not to be in a hurry! If you are, you can try to cover as much os the trip as possible by hitching, Make sure you know the schedule of the last train that will get you to your destination on time, so you can catch that when you see you're not going to make it.

It pays off to make a rainproof sign yourself; you simply put an A4-size of cardboard inside one of those A4-plastic covers. Then all you need is a felt-tip pen and some sheets! To my experience, hitching rides is most successful when you have your sign for passing cars AND you can ask driver at a gas station or a traffic light.

In general you should always be polite and preferably not rape or murder the driver who picks you up, otherwise you spoil the name of us hichhikers, If the driver turns out to be drunk or tries to do nasty things to you, you ask him to stop and get out. A great way to make a driver stop if he doesn't want to is to pretend you are going to vomit or greak out. Good luck!

#### LODGING:

The best option is of course to stay at an AEGEE-member's place; some beautiful "things" have grown out of those nights, Another good one is to stay at the house of the last driver who gives you a ride, If you are not lucky, why not sleep ouside? When it's not raining or freezing, all you need is a sleeping bag and an insulation mattress, and a quiet spot....

#### EATING/DRINKING:

So far, you haven't had a chance to spend your % ECUs yet; they should go into food and drink. Of course supermarkets are usually cheapest, but you can get cheap meals in most mensae (university restaurants) too. In Southern Europe price differences between various types of bars can be huge; in Madrid 1 paid everything between 60 and 600 pesetas for a beer.

You can take advantage of price differences between countries (cigarettes and alcohol cost about six times as much in Scandinavia as in Spain, for instance), Finally, there are the tax-free zones (Andorra!) and ferries, Who knows, you might end up making money while travelling!



# Interview with Mr. ALAN SMITH, Director of the ERASMUS Bureau

What is the Erasmus Bureau?

The Erasmus Bureau is a Consultant Committee to the Commission, in matters dealing with Mobility Programs. The actual policy is a Commission's responsability whereas the Erasmus Bureau is interested in applying provision assistence to the Commission, particularly on selection of the programs from Universities, the ICP's. Though all the final decisions on the programs are taken by the Commission itself, it is The Erasmus Bureau which does the detailed work on the applications, implying quite some influence on the process. Thus on all concerning Erasmus, the qualitative assessment is dealt by the Erasmus bureau, while the political assessment is a task of the Commission, which in choosing the programs seeks a balance between area distribution and nature of the programs.

What does the Erasmus Bureau do?

The Erasmus Bureau has three major areas of intervention:

policy advice to the Commission, information, publications on the Mobility Program. It also coordinates the national grants for students, the national academic recognitions, an the informations on the ECTs program.

How many people work in the Erasmus Bureau?

56 people work in the Erasmus Bureau with a contract of unspecified duration, plus seasonal workers coming from universities. Students tend to work on technical service tasks; some have done stages at the Erasmus Bureau, some have worked for it on fairs, like the European Student Fair, or worked interpreting the glossary of the technical words.

How to join the Erasmus Bureau?

The Erasmus Bureau is a private organization. The staff comes from all the EC countries, very important aspect in order to get knowledge of the different university systems throughout the Community. Normally, when there is a job vacancy, we advertise it on the newspapers throughout Europe; or in Universities if we are looking for additional staff. Another way would be just to write us. It has happened before that someone wrote and found a place availabel! I wish to emphatize though that working for the Erasmus Bureau is not exactly as glamourous as one might think. It is mostly paper work!

Is the Bureau completely aware of what is going on concerning: -academic recognition - selection of students in the Universities - amounts of grants awarded - services offered by universities to Erasmus students?

The most serious answer is no. The Bureau does not have the means to know everything that happens within Erasmus. We are concerned with getting the most important inforfmations, mainly requiring annual reports on the different programs or external evaluations, i.e. form NGAA's, and through the reports the students turn in at the end of their exchange. This way we get the necessary feedback for coordination.

What do you think is the role of student associations active in this field?

One of the successe of the program was the getting together of the associations. They play an important role in information; they provide a good feedback to the Bureau and a strong practical support.

What do you expect from AEGEE and other students associations?

I personally see two different kinds of associations: one lobbying to influence on a macrolevel, the other seeking to influence on day to day life. The Erasmus Bureau needs especially this more practical approach.

What are the expecifications and hopes for the Erasmus program?

The Erasmus Bureau is hoping on the next two years to improve bothe the quality and diversity of the programs and to reach a consolidation of the infrastructure. Some questions remain to be solved, such as the need for more institutional involvement, the need to mantain the motivation of the individual professors, essential for Erasmus and to get more student involved in it. This will only be possible with more funds. The last, but very important question is what would happen of the extimated 90 percent of student not partecipating in the program. Not much is being done for them now, mainly for lack of funding, but maybe it will be possible to give even to these students a European dimension, i.e. through more exchange programs between professors throughout Europe, enabling

these students to have courses in different languages and to experience a different approach to the subjects.

EFTA countries entry; how is it goinng to affect the program?

The entrance of the ERTA countries will certainly represent an enrichment, resulting in a mutual benefit. The Erasmus Bureau expects students and universities from these countries to be eager to participate, contributing in the success of the Erasmus Program.

When will it become normal to study abroad?

My answer is: hopefully soon. It will take an outstanding chance of mentality from both students and universities. Although the general attitude has changed a lot already since 1985-86, when spending a year studing somewhere else in Europe was not an opportunity students considered at all, still a lot has to be done to reach this goal. The main challenge is to keep up the momentum created by students and universities. Moreover, the Bureau doesn't want Erasmus to be an èlite program; therefore more actions have to be taken, adding a dimension of social and cultural policy, only possible through a raise of the budget.





# MINUTES OF THE EnWG WEEKEND IN THE BLACK FOREST (17th - 19th Jan)

The last meeting of the Environmental Working Group took place in the Black Forest form the 17th to the 19the of January. The first part dealt with our WG in general while the second part focused on the 3rd Environmental Week.

#### A. ENWG IN GENERAL

To be able to plan in longer terms, we agreed on a TIME SCHEDULE of meetings for 1992 and 1993. You will find it at the end of these minutes. It includes by-annual 'EnWG Week-Ends' which will consist of a general meeting to prepare projects, short lectures on environmental topics and activities to get acquaintant with each other and the surrounding. To avoid collisions between EnCongresses and EnWeeks, the EnWeek 1993 will take place in autumn. Offering local EnWGs something to work on during the break between the EnWeeks 1992 and 1993, local teams can present a specific environmental topic on a 'COMPETITION ACADEMY' in the beginning of 1993. Detailed conditions will be published after our next meeting in Riga.

Patric klwin-Breteler (AEGEE Utrecht) was elected treasurer of th EnWG (Schoutenstraat 3 Bis, NL-3512 GA Utrecht, 31 30 369018). New speaker and vicespeaker will be elected during our meeting in Riga, Candidates (only present WG members) can apply to the current speaker. A written presentation can be published in an EnWG-Letter, if they are sent to AEGEE Münster (Postfach 1244, D-4400 Münster) until the 31st of March.

Four workshops achieved the following results (for further information or participation you can contact the persons mentioned in brackets):

#### I. ENVIRONMENTAL PROTECTION WITHIN AEGEE:

Aseries of guidelines will be worked out to help antennae considering environmental aspects in the organization of AEGEE events. The subjects are paper, transport, dishes, congress materials, and environmental topics on congresses, Finally the information are collected in a pool and will be up-dated regularly. (Eelco (Utrecht), Wytske (Nijmegen), Henning (Münster)).

#### ILPR OF THE ENWG

- 1. The PR GROUP was founded to deal with the improvement of the EnWG's communication within the WG itself, within AEGEE in general and to external contacts. (Michèle (Amsterdam)).
- 2. The Study Group 'SOLAR ENERGY' was established to work detailed on one specific environmental topic. The results will be published in a booklet which will show the chances of this technology from different points of views (technology, urban planning, economy, ...), (Max (Milano), Paw (Aalborg), Stefan (Münster)).

#### III. GENERAL AIMS OF THE ENWG:

The main task of our WG is to collect compare and spread information on environmental problems. In the future the role of comparisms will be stressed especially by

- -Resumes of the local Environmental Weeks at a meeting shortly after the EnWeek (Nijmegen, 6th to 8th of June)
- -more Excursions
- -more Seminars and Workcamps

#### IV. FUNDRAISING OF ENVIRONMENTAL PROJECTS:

The Cooperation with the Fundraising WG and authorities will be intensified, Stronger contacts of the EnWG treasurer to antennae, organizing environmental projects in AEGEE, should help them in their efforts to raise funds. At the same time the FWG will receive more detailed information for its calendar of events (Patric (Utrecht), Stefan (Münster).

#### B. ENVIRONMENTAL WEEK

The EnWeek's duration was extended from the 27th of April to the 8th of May 1992. Its subject will be "CONSCIOUSNESS AND ENVIRONMENT". You can examine aspects of the society as a whole (governments, media, industries, enbironmental organizations ...) and of the educational system (school systems, studies, environmental training of companies). Apart from an inquiry, which will be worked out by Nijmegen, reserach on the environmental situation at your own university (recycling, waste, studies, ...) and excursions to hot spots would be very useful. It will now only be important to raise the awareness, but also to transfer it into actions!! Think of common projects with antennae in your neighbourhood other associations at your university.

The role of the CO-ORDINATOR should mainly consist on PR. The brochure 'European Environment' with the resumee of the EnWeek 1991 cna be used to attract lecturers or sponsors for your local events in 1992. A poster will probably be available at the end of March, By offering your support in PR we try to stress the European sharacter of events during the EnWeek and to reduce your costs.
